Public Safety

Police Department:

Commander Beasley read the stats in the packet and stood for questions. Councilor Mariscal asked if there was a welding truck that was stolen and Commander Beasley replied yes there was.

Fire Department:

Fire Chief Hope stated that stats are in the packet that it had been a standard month. The 911 Memorial Exhibit venue has changed location to the Bulldog Bowl parking lot due to the size of the truck.

Community Development

A. *Discussion and possible action on Artesia Aquatic Center Budget and Staffing

Community Development Director Jim McGuire stated that when meeting with the budget and staffing committee there was an increase of personnel cost of the aquatic center for custodian staff and contract custodians of an adjustment of \$8,000.

Councilor Youtsey made a motion to adjust and approve the aquatic center budget. Second by Councilor Bratcher and upon vote, the motion passed 8-0.

B. *Stats

Jim stated that he has the monthly reports for building inspections and then stood for questions.

Infrastructure

Infrastructure Byron Landfair discussed a couple of updates and problems they have with the truck shed, they have started their excavation and about half the pad is in an old burn section, about 3ft will have to be taken out to get it structurally sound to put a building; which Byron will then bring to Council as soon as he gets an estimate. Also, the last piece of the Hermosa extension is done it is striped and opened. The Industrial Park is over with EDA and Byron is expecting their review next week and he will answer them back and it looks like we will be going to bid in about two months on that project. Bryon stated that the spring cleaning has begun as the alleys have become really bad. They are short on staff and the on call budget is getting thin. Byron has been bringing in folks to help out trying to get some of these alleys cleaned up that are the worst. The Infrastructure Department will be at or a little over budget for professional services. Bryon then stood for questions.

Councilor Moreau asked if the Boys Scouts have started out with Artesia Clean & Beautiful. Byron stated Artesia Clean & Beautiful is not quite on-line yet which he thinks in the next couple of weeks they will start doing their hires and then getting out there.

Councilor Youtsey asked Byron if he could use some of the solid waste money to clean up some of the alleys. Byron replied that they could but it is not in the line item; he has reserves that he can move over if they choose to do that but that the line items for the year are at the end of that fiscal year. Councilor Youtsey stated that he's in agreement with this if we need to get the alleys cleaned up with action by the Council if we have the extra money.

Mayor Miller stated that they might want to get with Aubrey to determine how to pay for it.

Mayor Pro Tem Hill asked about the status on the Freeman water line. Byron stated that there are two pieces; an emergency valve on 1st Street, when they get an insurance certification to the state, then they will release the traffic control permit where the valve can be replaced and are

hopeful that will happen in the next couple of weeks the contractor is ready Thursday if the certification is ready. On the Freeman loop line everything is in place and they are waiting for the two permits from the State highway for the bores for 1st Street and across Hwy. 82. We will need to talk with AirGas and Holly to get permission from these two landowners. Byron stated that the plans are just about complete that it's not a complex job. Mayor Pro Tem Hill thanked Byron.

City Assistant Clerk/Treasurer Summer Valverde presented to the Mayor and Council for consideration and approval, the clarifying Resolution – 1755 for the PERA Employer contribution match of 25% by employee and 75% by the City new additions in the coming years. Aubrey had PERA look over the resolution which they are good with. Summer stated that the resolution is an overall breakout of total contributions and then stood for questions.
